Border Rivers and Moonie draft Water Entitlement Notice 2024

This is a draft Water Entitlement Notice published by the chief executive on 2 August 2024 under the authority of section 72 of the *Water Act 2000* (the Act). All individual water licence related information is current at 1 June 2024. (Please note: This Water Entitlement Notice may not include changes to individual information potentially resulting from any water licence dealings that might have occurred since 1 June 2024.)

Water entitlement notice

- 1) For sections 70 and 71 of the Act, the chief executive may make a water entitlement notice for the purpose of implementing a water plan.
- 2) This draft Water Entitlement Notice provides for the granting and amending of water licences in accordance with Parts 1 and 2 below.

Part 1 Granting a water licence - Water Act 2000, section 116

The chief executive is proposing, consistent with the direction made under section 25(1)(c) and consistent with section 62(2) of the Water Plan (Border Rivers and Moonie) 2019, to grant the following water licences for the taking of overland flow water to which the plan applies, using existing overland flow works¹ which are identified in this water entitlement notice, and having regard to certified reports² which have been previously provided to the department —

- water licences in schedule 1, for the Border Rivers catchment;
- water licences in schedule 2, for the Moonie catchment.

The licence has effect from the day the licence is given to the licensee.

Part 2 Amending a water licence - Water Act 2000, section 133

The chief executive is proposing, consistent with the direction made under section 25(1)(c) of the Water Plan (Border Rivers and Moonie) 2019, to amend the following water licences —

- water licences in schedule 1, for the Border Rivers catchment;
- water licences in schedule 2, for the Moonie catchment.

A water licence is inconsistent with this water entitlement notice unless the water licence is amended to include the conditions stated in the attached schedule. The amendments to the water licences take effect from the day the chief executive gives the licensee the amended licence.
